### Information to Authors

**The Indian Geographical Journal** is published half-yearly in June and December by The Indian Geographical Society, Chennai. The peer reviewed journal invites manuscripts of original research on any geographical field providing information of importance to geography and related disciplines with an analytical approach. The manuscript should be submitted only through [online mode](#).

#### General Guidelines for Manuscript Preparation

The title should be brief, specific and amenable to indexing. Author's name and affiliation should appear in a separate title page and should contain Title, Authors, Affiliations, and e-mail address of the Corresponding author and should not appear anywhere in the text so that the article could be impartially assessed by a referee.

Not more than five keywords should be indicated separately; these should be chosen carefully and must not be phrases of several words. Abstract and summary should be limited to 100 words and convey the main points of the study, outline the results and conclusions and explain the significance of the results.

If you include figures that have already been published elsewhere, you must obtain permission from the copyright owner(s) for both the print and online format. Please be aware that some publishers do not grant electronic rights for free and it is informed that IGS will not be able to refund any costs that may have occurred to receive these permissions.

Acknowledgements of people, grants, funds etc. should be placed in the title page. The names of funding organisations should be written in full.

References should be listed in alphabetical order, identical to MLA format. The list of references should only include works that are cited in the text and that have been published or accepted for publication.

## Online Manuscript Submission Process

The manuscript should be uploaded in Microsoft Word Document (.doc, .docx) as follows:

**Title Page:** Title of the Manuscript, Corresponding Author Name and Address (*complete postal address with contact details including phone and email ID*) and acknowledgements (*if any*)

**Full-Length Manuscript:** The main text part should **not** contain author(s) name or identities. The main text can be divided into the sections viz. Title, Abstract, Keywords, Introduction/Background/Literature review, Study area, Methodology, Results, Discussion, Conclusion and References. Please note that all figures and tables should be submitted separately.

**Tables:** All tables should be consolidated in a single MS word document with proper captions and foot notes (if applicable). The tables should be numbered in a sequence (*Table 1, Table 2 etc.*) and caption should be explicit

**Figures:** All figures/graphs/charts/maps should be submitted in the final form in JPEG/PNG format within a single MS Word document. The authors should however agree to revise the maps/charts for reproduction after the article is accepted for publication. Each figure should have a concise caption describing accurately what the figure depicts.

All new manuscript submission should be accompanied with a declaration stating that, “It is declared that the manuscript submitting to IGS journal is original work of the author(s) and it is not published already or submitted elsewhere for publication”.
